This year we will be adding a deck hockey and upgrading Scott Park playground area and making it handicap accessible. Hope you have noticed over the last few years new businesses have been coming to Carothers Avenue, please patronize them when possible.

We are hoping to see more businesses join them. School will be out soon and more children will be out at play, so please drive carefully. As always I have enjoyed representing this ward and I am here for you to hear your concerns.

Dear Residents of the Second Ward of Scott Township,

This is the eighth year that I have had the honor of being your commissioner, and I thank you for entrusting me with this duty.

This has been a very difficult year with many hard fought political battles. I have been very vocal on opposing the steep slope ordinance violations that I believe have occurred. As you are aware most of the homes in our ward have rear yards that border very steep slopes. The steep slope ordinance was implemented to protect the home owners when new developments are planned from possible flooding and land slides. Most of the existing storm water facilities in our area are at full capacity and cannot convey additional storm water effectively and the soil composition in this area is extremely slide prone (this year I have fought against three areas in the township where steep slopes have been disturbed). I have not made great progress and face severe opposition but will continue to oppose any disturbance of the slopes that violate the township ordinance that could possibly put our homes at risk.

I have also been vocal at opposing the construction of a \$750,000.00 (approximately) hockey deck that is designed directly behind some rear yards on Lindsay Road bordering Scott Park. I have concerns that the building of this hockey arena will eliminate the parking that is greatly needed in the park, particularly in the summer months when the ball fields are in use, the picnic groves rented, and the pool is at full capacity. I do not want the parking to pour onto lower Lindsay Road adjacent to the park creating a nuisance for Lindsay Road residents. I feel we can construct a hockey deck in the park and conserve the much needed parking spaces with proper engineering. I have also been asked

by our neighbors who's back yards border the park if the township could place the parking areas against their property and consider moving the deck behind the basketball court so that the noise from the hockey games is not in their yard and does create a unneeded disturbance.

In closing the number one request that I receive from residents throughout the township is if the housing codes could be better enforced, eliminating or repairing blighted properties and also to have homes that are unsightly or in disrepair brought up to code. Blighted properties do not attract responsible home owners or responsible tenants. We have a great township that the residents are proud to call home and we certainly do not desire to attract neighbors or landlords that do not keep their properties up to code.

Please attend the township meetings, a huge percentage of your tax dollars are allocated to local governments. Many residents will pay more in county, school, and township taxes than they do federal taxes and have no idea what their tax dollars are being spent on or if they are utilized in effective positive ways. I will be seeking a third term in the spring election and I am asking for the residents support.

Hello fellow residences of Ward 4. I hope all is well and you are looking forward to Spring. There is good news for those who travel through the intersection of Bower Hill Rd. and Kane Blvd. Finally, a request by the Township for the installation of a traffic signal was made and approval was granted by the PA Department of Transportation. This will make for a safer and improved capacity of the intersection. No date has been set for the installation; however with design, reviews, ordering equipment and installation and such, we are looking at it as maybe an early Christmas present. The Road Program is in high gear and anxious to get started. Our ward, using the allotted funding, can pave twice the distance by using a procedure used by the Dept. of Transportation. Poor base areas and pot holes, would be addressed first, as in any application. The savings is produced, by milling 1 ½" versus milling 3 ½". This method has been adopted by two other commissioners to increase the length of paving in their wards. Shireville and Betram Drives will be paved this year. However, they cannot be completed using the cost saving method since they have concrete bases.

Therefore, they must be milled full depth to prevent future damage to the new wearing and base course. The remaining length of Norsen Dr. will be completed using the 1 ½" milling method to match the stop line of last year. Residents on Vanadium Road, I ask for your patience; please be informed that, due to major repairs required to curb and sidewalk, the paving of the road will be scheduled for next season so that funding can be allocated for the necessary repair.

The township is addressing some issues with the new swimming pool and hopefully they will all be addressed for the upcoming season. Other new projects and improvements are proposed for our Parks. Your voice in the township matters and can be heard at township meetings. I believe in integrity, accountability, good work ethics and honesty. We work for you and if you like or dislike something, you must let us know. If you see something that does not look right, call. The way to eliminate a concern is to let the proper people know before it turns into a problem. Have a good year and thank you, Dave.

Let me begin by saying thank you for your support, and I am truly honored to represent each and every one of you. I would also like to thank my fellow Commissioners, our Township Manager Denise Fitzgerald, Police Chief Jim Secreet, Employees of Scott Township, and our Management team.

Several Public Safety issues were addressed, some of them were specific to the 7th Ward, while others pertained to the entire township. We worked diligently to ensure the safety of our residents of the entire township.

A few general examples are the implementation of new street lighting, new street signage, and road repair/improvements. Speeding on our streets was addressed with help from our Police Department by installing speed monitoring devices in both District 1 and District 2 of the 7th Ward to track and identify speeding patterns. Police patrols were increased in the vicinity to enforce traffic laws if necessary.

We would like to again emphasize that everyone drive carefully, obey all posted speed limits and detours, as well as traffic signs and signals when navigating our roadways.

In District 1 of the 7th Ward, I attended meetings held by Kings Grant, Paul Manor, and Jamestown Condominium Associations. Afterward, I learned of issues pertaining to code enforcement, recycling, and also speeding and parking.

We were able to assist with code enforcement where applicable, we acquired an additional recycling dumpster, and we also acquired a few recycling containers. We installed updated street signage in key locations to assist motorists/pedestrians with road way traffic hazards and patterns. As mentioned previously, we monitored speeding patterns and Police patrols were increased in the vicinity to enforce traffic laws if necessary.

In an effort to ensure the safety of those residents in District 1 who were affected by the Twin Hills Controlled Archery Hunt, we issued letters outlining the court ordered mandatory requirements pertaining to the controlled archery hunt.

In the spring of 2016, a number of residents of the 7th Ward expressed an interest for a Pickle Ball Court at Scott Park. With guidance and assistance from Director of Public Services Randy Lubin, and Public Works Supervisor Bert Smelko, a new Pickle Ball Court became a reality. I have learned a great deal from Randy and Bert, and I look forward to the continued exchange of ideas and collaboration.

To better serve Scott Township, and again with assistance from Police Chief Jim Secreet, we were able to implement a Safe Exchange Zone. The Safe Exchange Zone is located on the library side of the township building and it is under 24 hour video surveillance. The objective of the Safe Exchange Zone pertains to anyone with custody exchange concerns, and internet or local purchase concerns. Please make use of this benefit and contact the Scott Township Police if there are any issues.

Because of their sacrifices and professionalism, the Scott Township Board of Commissioners issued a Proclamation to our Police Department for Law Enforcement Appreciation Day which was held (June 11, 2016-Public Safety Day), and again on (January 9, 2017-Law Enforcement Appreciation Day).

In collaboration with the Pennsylvania Game Commission and IT Director Jay Cherep, we were able to offer a presentation to address questions and concerns regarding Coyotes observed not just in the 7th Ward but throughout all of Scott Township.

With the assistance of our three Proud and Distinguished Fire Departments and the Scott Township Emergency Medical Services (EMS), we implemented a Community CPR class for all residents of our Township. The program was a great success. This project could not have been coordinated without the help of Assistant Township Secretary Lisha Mihalko.

As a loyal supporter of the Scott Township Public Library, I commend Director Gina Leone, the dedicated Library Staff Members, the Board of Directors, and Friends of the Library. Together, they all contribute in making the Scott Township Public Library a wonderful township resource. Last year, the Scott Township Board of Commissioners purchased a table for the annual Trivia Night fundraiser. It was a great experience had by all.

Bower Hill VFD is one of the 3 Fire Departments that serve the over 17,000 Scott Township residents and businesses. Bower Hill is a completely volunteer fire department with approximately 40 members who can respond to the calls for assistance from the residents and businesses, regardless of the time of day.

Here are some ways that you can support Bower Hill so that we can continue to provide fire service to the residents and businesses of Scott Township.

1. **BUY-A-BRICK** – We are currently selling bricks that you can personalize. These bricks will be displayed on the front of our building for everyone to see. # 2017 Road Program

Road work is scheduled to begin on or around June and should be completed by September. The Scott Township Police Department consists of 21 full time sworn officers and answers an average of 5,000 complaints a year and about 450 arrests. The Department has 2 bicycle Officers, 1 full time Investigator, 1 K-9 Team and a School Resource Officer assigned to the CV Intermediate Unit. The Department is also very active with several Joint Task Forces, including The District Attorneys Narcotic Enforcement Team, The South Hills DUI Task Force and the SHACOG Critical Incident Response Team.

## **SERVICES**

**Fingerprinting** – The Police Department provides fingerprinting services to residents and employees of businesses located in Scott. There are only several officers that do the printing so you should call ahead for an appointment. Most appointments are scheduled between 3pm and 5pm Sunday - Thursday. There is a \$10 fee for this service. **Call Officer Doug Burek to schedule an appointment @ 412-276-7725 ext 281.**

**Incident Reports** – If you are involved in an incident and need a copy of the report you can **contact the Police Secretary, Franny Morelli @ 412-276-7725 ext 507.** The report will only be released if the incident is closed. A current or ongoing investigation will not be released. If you want to file a report for an incident you should call the emergency dispatch @ 9-1-1. An officer can come to your residence if you live in Scott or you can go to the Police Station to make the report. We do not take reports over the phone.

**Identity Theft Presentations** – One of the fastest growing crimes in America is Identity Theft. Our Officers provide talks to groups to give information on ways to protect themselves from becoming a victim. **Contact Sgt. Jeff Skees @ 412-276-7725 ext 248** for information on these sessions.

**Traffic Complaints** – One of the most common complaints we receive are traffic related. We feel that the most effective way to solve these complaints is by presence and enforcement. Two ways the public can assist us is one, to notify us when there is a specific problem. Provide us with information on where the problem is occurring, when and by whom (vehicle description).

Secondly, if you reside in a residential neighborhood and are willing to permit Scott Officers to monitor traffic from your driveway, we want to know. Upon advising us, we will request that you complete a permission form and your driveway will be put on a list of locations that our Officers can park at to monitor traffic. **Call Sgt. Steve Fury @ 412-276-7725 ext 247 for more information.**

**Suspicious Activity** – Although our Officers patrol the Township thoroughly, we cannot do it by ourselves. We need your help in watching for any suspicious activities in your neighborhood. When you see something that doesn't seem right, call the police, we can investigate. Although we prefer that you give your name and number to the Police Dispatch in case we need to obtain more information from you, you can remain anonymous if you prefer. **Call 9-1-1, if it needs immediate attention. For general information or comments, call 412-276-7725 and leave a message.**



**Abandon Vehicles** – The Township does have an ordinance on abandon vehicles. The Police Department only investigate abandon vehicles on public streets. Abandon vehicles are those that are parked on the street with either an expired inspection sticker or registration plate. Vehicles that are parked on private property are investigated by the Township Ordinance Officer, Todd Tulowitzki. **He can be called @ 412-276-5300 ext 216.**

**On Street Parking** – Some areas of the Township have restricted parking from 2 am - 6 am. These streets are posted with signs at least on each end of the street. Vehicles must be completely off the road to be in compliance. Should a temporary situation arise that a vehicle may need parked on the street (driveway repair, guests, etc.) you can call the non emergency dispatch or the Police Department Administrative number between 8 a.m. and 4 p.m. Monday thru Friday.

**Door to Door Solicitation** – Scott Township has a Solicitation Ordinance that requires individuals to obtain a permit before soliciting. Application can be made to the Police Secretary at the Police Station. Soliciting is not permitted past dusk and is not permitted after noon on Saturdays, and not at all on Sundays and Holidays.

**Vacation Checks** – If you are leaving your residence for an extended period and want the Police to make checks of the property, you can call 412-276-7725 and leave a message for an Officer to return your call or email [police@scotttownship.com](mailto:police@scotttownship.com). Provide your name, address, contact phone number, dates you will be gone, and any other information pertinent to the property (i.e. lights on timers, cars in driveway, etc.) Also, if possible, please indicate a local emergency contact name and number for us to call should a problem arise.

## TOWNSHIP OF SCOTT 2016 Proclamations:

On February 23, 2016 the Board of Commissioners approved a proclamation designating March 7<sup>th</sup> – 13, 2016 as MS Awareness Week.

On August 9, 2016 a proclamation was provided to two of the Scott Pool lifeguards, Ethan Winger and Ross Manganaro for saving the life of a three year old boy.

On September 27, 2016 a proclamation was given to a local business; Mustin Chiropractic for 25 years of service. Mustin Chiropractic was and continues to be a proud business of Scott Township.

On November 22, 2016 Scott Township recognized Congressman Timothy Murphy for great bravery through the rescue of an unresponsive man found in the Capital Hill building.

## Code Enforcement

When you are spring cleaning, keep in mind that it is unlawful to have unsightly debris or junk in your yard. It is also illegal to have unregistered or uninspected vehicles on your property.

**Haul away bags or dumpsters** can be placed on your property for clean up or a construction project for a maximum of **10 days**.

**PODS** are a convenient way to pack your belongings for storage elsewhere. Again, they can be on your property for a maximum of **10 days**. You **cannot** use trailers for storage on your property.

**Parking on your lawn or in your yard is illegal** and the Police Department and Code Enforcement are working together to step up enforcement. Officers will be looking for illegally parked cars evenings and week-ends and furnishing the information to the Code Enforcement Office.



**Chicken coops** are becoming increasingly popular, but township ordinances prohibit keeping poultry or farm animals. Therefore, raising chickens is not permitted in Scott Township.



### Rental Properties

Under PA Act 21, effective June 1, 2015 owners of all rental properties will be required to install carbon monoxide detectors. This will become part of the inspection process.

### Recycling

Please place your recyclables in your new bin with the lid opening toward the street with a minimum of three feet between each container and other objects. Do not park your vehicle near the container.



The truck has a mechanical arm that reaches the bin so it is very important that you follow the placement instructions.

# Scott Township - Garbage & Recycling Pick-Up

## 1. REGULAR CURBSIDE COLLECTION:

Garbage and refuse should be placed at the curb the night before your scheduled pick-up.

## 2. GUIDELINES FOR COLLECTION:

- Garbage should be in properly secured containers or plastic bags.
- All furniture items, appliances, household goods and disassembled children's swing sets will be accepted at curbside.
- Carpet should be rolled and tied in lengths not to exceed 48 inches so that one man can lift.
- Empty paint cans and/or dried paint is acceptable. Paint can be dried by air drying or soaking up with newspaper or kitty litter. Lids should be left off.

## 3. EXCLUDED ITEMS:

- Building materials may be picked up for a fee by calling **Waste Management at 1-800-866-4460**
- Tires
- Automobile parts, including wheel rims.
- Trees and branches.
- Ashes from furnaces and fireplaces.
- Stones and dirt, liquid paint.

## 4. RECYCLING

Recyclables should be placed loose in a single container.

**SINGLE STREAM RECYCLE:** Residents do not have to separate the plastics—Type 1 through 7, metals, glass and papers.

## ACCEPTABLE ITEMS INCLUDE:

- Metal:** Metal food cans, aerosol cans (empty), aluminum foil and foil products (clean), beer and soft drink cans
- Plastic:** Plastic baby wipe containers, bleach, detergent, household cleaner bottles, yogurt cups, food containers, margarine tubs, shampoo bottles
- Glass:** Beverage bottles and food jars (clear, brown, amber and green)
- Paper:** Paperboard boxes (cereal, tissue, shoes etc.), white office paper, computer paper, magazines, newspapers, advertising inserts, junk mail (including envelopes), catalogs, phone books, paperback books, coupons and receipts, paper bags and shopping bags (handles removed), corrugated, *note: corrugated must be tied or bundled no longer than 14" x 14"*.

**Recyclables will be picked up every other week on your regular garbage pick-up day.** The municipality will be divided into two sections, (A) and (B). Please refer to the street listing ([visit www.scott-twp.com](http://www.scott-twp.com)) to be sure when service will be provided and refer to the calendar below.

**5. HOLIDAY SERVICE:** If a holiday falls on Monday, pickup will be one day later, Tuesday. **Observed holidays for 2017 are:** New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas Day. If the holiday should fall on a weekend, your pickup day will not be affected.

## 6. APPLIANCES CONTAINING REFRIGERANT:

The contractor will collect such items as refrigerators, freezers, air conditioners, dehumidifiers, water coolers, etc.; however, the item must have a sticker certifying that refrigerant has been removed. If it does not have the sticker, it will not be picked up because it is unlawful for the contractor to dispose of these items containing refrigerant. To save refrigerant removal costs, it is suggested that residents have the company delivering the new appliance dispose of the old appliance.

## 7. QUESTIONS REGARDING REFUSE OR RECYCLING COLLECTION AND BILLING CALL:

Please look for your street name on either Schedule A or Schedule B for your recycling pickup date.

**Regular Curbside Collection: Garbage and refuse should be placed at the curb after 6 p.m. on Sunday and before 6 a.m. on Monday for collection.**
