To the Residents of Seoff Townships

This Spring issue of Scott Topics is filled with upcoming events and information that is useful for every resident.

This past October, the Township Engineer reported to the commission that in addition to leaks and piping needing replaced in our pool that there was significant deterioration and spalling of the concrete on the walls of the pool itself. With that said, we are building a new pool to replace the old one built in 1968. A committee has been formed so when the pool closes in the fall of 2015, we will be ready to begin building the new pool to be ready for the spring of 2016. The plan of the new pool includes "zero" entry walk-in area, a 50-meter competition swimming area, diving board, a dual water slide, rock climbing walls and a new water feature.

On May 2, 2015 at 1 p.m. the township is partnering with Heidelberg and Carnegie for a Tri-Community Parade. The parade route will begin at the Heidelberg Fire Department, continuing along Route 50 to Carothers Avenue and end on Main Street in Carnegie at their municipal building.

This issue of the Scott Topics will focus on upcoming events and usual seasonal issues, as well as provide you with some useful information regarding the most recent legislation of general interest to our Scott Township residents. I hope this issue of the newsletter is both informative and helpful to you.

2nd Ward

With Swallow Hill Road finished and being enjoyed by most of the residents in Scott Township and the surrounding communities, the township is moving on with other major 2nd Ward projects over the next couple of years.

2015 is going to be a very busy time for 2nd Ward residents with many large projects scheduled. The sanitary sewer line on Clairview Drive will finally be repaired after 60 years of causing major problems for the residents. The storm sewer problem on Pine Trees will also be repaired so that the major flooding that has occurred since the plan was developed will be eliminated. These two projects will greatly improve the quality of life for the 2nd Ward residents served by these sanitary and storm sewer lines. There are plans to uncover and repair street drains in the 500 block of Lindsay Road when we repave a portion of Lindsay Road this summer. This should eliminate the garage and family room flooding on a couple of the houses when we have major storm events.

Scott Park will have two, or possibly three, major improvements over the next two years. The first will be a very large handicapped accessible playground installed, very similar to the one at Settlers Cabin Park (this should occur this summer). Even more exciting, we have formed a committee headed by Laura Hartman and hired an architect that has designed most of the newer major pools in the tri-state area (James Goldman) to design a new pool which is scheduled to be finished in May of 2016. The current pool is well over 40 years old and the concrete and filter lines have deteriorated way beyond permanent repair. The pool will

be temporarily repaired for use this year but as soon as the pool closes it will be demolished and a new pool will take its place over the fall and winter months. By the time this letter is published the plans should be complete and design drawings will be available at the township for all to view. There is also discussion taking place to develop a portion of the park by the basketball courts for a synthetic ice rink. The Scott Township Fire District has ordered a new ladder truck to serve the entire community and this will be funded by the township.

Since last year's letter I have had fewer complaints about parking in the grass areas in front yards. I thank you and so do your neighbors for your civic pride. You may have noticed the signs asking drivers to drive like their children live here and if you desire a sign for your yard there are some still available, please just call or e-mail me. In April you will be receiving new recycle receptacles that will make pickup fully automated. This will be a major adjustment for the residents but I believe after a couple of months we should be able to get used to it.

If I can answer questions or help with township problems please call me at 412-276-8623 or e-mail me at wellscommissioner@gmail.com. I have also been asked to let you know that the Wynnecliffe Manor Civic League has scheduled the sleigh and horses for Santa on December 12, 2015. The event will be the same as it has been for the past 60 years.

Thank you for affording me the privilege of serving you as your commissioner.

Code Inforcement

When you are spring cleaning, keep in mind that it is unlawful to have unsightly debris or junk in your yard. It is also illegal to have unregistered or uninspected vehicles on your property.

Haul away bags or dumpsters can be placed on your property for clean up or a construction project for a maximum of 10 days.

PODS are a convenient way to pack your belongings for storage elsewhere. Again, they can be on your property for a maximum of 10 days. You cannot use trailers for storage on your property.



Parking on your lawn or in your yard is illegal and the Police Department and Code Enforcement are working together to step up enforcement. Officers will be looking for illegally parked cars evenings and week-ends and furnishing the information to the Code Enforcement Office.

Chicken coops are becoming increas ingly popular, but township ordinances prohibit keeping poultry or farm animals, so raising chickens is not permitted in Scott Township.

Rental Properties

Under PA Act 21, effective June 1, 2015 owners of all rental properties will be required to install carbon monoxide detectors. This will become part of the inspection process.

Recycling

Effective April 1, 2015, Scott Township has gone to Automated Recycling.

Please place your recyclables in your new bin with the lid opening toward the street with a minimum of three feet



between each container and other objects. Do not park your vehicle near the container.

The truck has a mechanical arm that reaches the bin so it is very important that you follow the placement instructions.

You cannot store recycling containers in the front of your house.

Leaves can only be placed in 30-gallon compostable paper bags and tree trimmings are to be bundled and tied with twine in manageable 3' to 4' foot lengths. Each bag and/or bundle to be picked up should not exceed 40 pounds.

Scott Township - Garbage & Recycling Rick-Up

1. REGULAR CURBSIDE COLLECTION: Garbage and refuse should be placed at the curb the night before your scheduled pick-up.

2. GUIDELINES FOR COLLECTION:

- Garbage should be in properly secured containers or plastic bags.
- All furniture items, appliances, household goods and disassembled children's swing sets will be accepted at curbside.
- Carpet should be rolled and tied in lengths not to exceed 48 inches so that one man can lift.
- Empty paint cans and/or dried paint is acceptable.
 Paint can be dried by air drying or soaking up with newspaper or kitty litter. Lids should be left off.

3. EXCLUDED ITEMS:

- Building materials may be picked up for a fee by calling Waste Management at 1-800-866-4460
- Tires
- · Automobile parts, including wheel rims.
- · Trees and branches.
- · Ashes from furnaces and fireplaces.
- · Stones and dirt, liquid paint.

4. RECYCLING

Recyclables should be placed loose in a single container.

SINGLE STREAM RECYCLE: Residents do not have to separate the plastics—Type 1 through 7, metals, glass and papers.

ACCEPTABLE ITEMS INCLUDE:

- Metal: Metal food cans, aerosol cans (empty), aluminum foil and foil products (clean), beer and soft drink cans
- Plastic: Plastic baby wipe containers, bleach, detergent, household cleaner bottles, yogurt cups, food containers, margarine tubs, shampoo bottles
- Glass: Beverage bottles and food jars (clear, brown, amber and green)
- Paper: Paperboard boxes (cereal, tissue, shoes etc.), white office paper, computer paper, magazines, newspapers, advertising inserts, junk mail (including envelopes), catalogs, phone books, paperback books, coupons and receipts, paper bags and shopping bags (handles removed), corrugated, note: corrugated must be tied or bundled no longer than 14" x 14".

Recyclables will be picked up every other week on your regular garbage pick-up day. The municipality will be divided into two sections, (A) and (B). Please refer to the street listing (visit www.scott-twp.com) to be sure when service will be provided and refer to the calendar below.

5. HOLIDAY SERVICE: If a holiday falls on Monday, pickup will be one day later, Tuesday. Observed holidays for 2015 are: New Years Day, Memorial Day, Labor Day, Thanksgiving and Christmas Day. If the holiday should fall on a weekend, your pickup day will not be affected.

6. APPLIANCES CONTAINING REFRIGERANT:

The contractor will collect such items as refrigerators, freezers, air conditioners, dehumidifiers, water coolers, etc.; however, the item must have a sticker certifying that refrigerant has been removed. If it does not have the sticker, it will not be picked up because it is unlawful for the contractor to dispose of these items containing refrigerant. To save refrigerant removal costs, it is suggested that residents have the company delivering the new appliance dispose of the old appliance.

7. QUESTIONS REGARDING REFUSE OR RECYCLING COLLECTION AND BILLING CALL: Waste Management of PA at 800-866-4460.

Please look for your street name on either Schedule **A** or Schedule **B** for your recycling pickup date.

Regular Curbside Collection: Garbage and recycling can be placed at the curb after 5 p.m. Sunday.

- Plastic Containers (Food and beverage containers, water bottles, laundry detergent bottles, milk jugs, etc.)

WHAT TO DO WITH YOUR OLD RECYCLING BINS:

You may keep your old container and use as you please; however, it will no longer be acceptable for recycling. Should you want to recycle it, you may take it to a Scott Township drop off location, located at the *Public Works Building*; 2600 Old Greentree Road. Please stack your old containers in the dumpster provided by Waste Management.

Please note that the last recycle pick up for the current program will be the week of March 30, 2015. The automated program will only accept Scott Township approved recycling carts.

WHEN DOES THE NEW AUTOMATED SERVICE BEGIN?

Please continue to use your existing recycling bin until your scheduled pick up during the week of April 6, 2015. At this point, operations will have all equipment in place to provide automated service.

Thank you in advance for your cooperation.

PLACE RECYCLABLES IN YOUR NEW CONTAINER

Please place your new containers with the lids opening towards the street with a minimum of three feet between each container and other objects.

THIS NEW EQUIPMENT IS DESIGNED TO BE AUTOMATED SO THE DRIVER DOES NOT LEAVE THE CAB. THE TRUCK HAS A MECHANICAL ARM THAT REACHES THE BIN; IT IS VERY IMPORTANT THAT YOU PLEASE FOLLOW THE PLACEMENT INSTRUCTIONS ON THE LID EACH TIME YOU PLACE THE BIN OUT FOR PICK UP TO PREVENT ANY INTERRUPTION IN SERVICE.



Home to a Natural Woodland Area with Walking Trails


If you like to watch birds, experience nature with a brisk walk in the woods, or just want to take your dog out for some morning exercise, the Kane Woods Nature Area is the place to go. The nearly 80-acre nature preserve nestled in the heart of Scott Township is available for all

residents to enjoy. A series of trails guide residents through the forest and meadows where they can see oak trees, a meandering stream, and plenty of wild turkey and other woodland birds. Scott Conservancy volunteers maintain the Kane Woods for the enjoyment of the community and to preserve a woodland environment in the heart of our neighborhood. We welcome you to our trails and nature area and hope you will consider volunteering with the Scott Conservancy or

making a donation to support the mission of preserving Scott Township's green space.

The trails are named after significant events from the Whiskey Rebellion in July of 1794 that engulfed what is now Scott Township. The last few years a group of dedicated individuals known as Wayne's Legion recreated those days with an encampment and a demonstration of the federal troops and rebels in the conflict. These soldiers of the Fourth Sub-Legion of the United States, known as Wayne's Legion, are committed to accurately recreating the campaign and camp life of the Army of the United States from 1792-1796, and they specifically recreate the twelve American

soldiers who were sent to defend Bower Hill, the home of General John Neville, during the Whiskey Rebellion. This unit is based at the Woodville Plantation, the 1774 home of Colonel Presley Neville, and is funded and administered by the Neville House Associates.



Three parking lots are available for visitors. One is the Whiskey Point Trailhead located at 1461 Scrubgrass Road directly across the Veteran's Memorial Bridge. The second parking lot is the Scrubgrass Run Trailhead at 1459 Scrubgrass Road, and the third place is the Jewish Community Center parking lot on Kane

> Blvd. All three areas provide easy access to the trail network.





Real Estate Taxes

Lisa M. Riley, Tax Collector

The Scott Township Commissioners and School Board set the millage rates yearly when they adopt their budgets. The Allegheny County Board of Assessors determines the assessment of each property. The township or school district tax is calculated by multiplying the appropriate millage by the full market value as determined by the Allegheny County Office of Property Assessment.

On July 1st of each year the Scott Township Tax Office mails the township and school district real estate tax bills. These bills are mailed either to the property owner, their mortgage company, or their designated agent. Every property owner whose real estate taxes are paid by August 31st receives a 2% discount. The face tax is due no later than October 31st, and a 10% penalty is added to any unpaid tax on November 1st.

PLEASE NOTE: TO AVOID A PENALTY, ALL PAYMENTS MUST BE POST-MARKED BY DUE DATE OR PRIOR TO DUE DATE, NO EXCEPTIONS.

Chartiers Valley School District also offers an installment plan as an option to paying the tax in one payment. In order to pay the school tax in installments, the property owner must pay by the following dates below in 4 equal payments at face.

Installment Due Dates

- 1st payment October 15, 2015
- 2nd payment December 15, 2015
- 3rd payment February 15, 2016
 - 4th payment April 15, 2016

The Tax Office regularly updates the real estate tax records using deed transfers and information supplied by property owners or their agents. Allegheny County provides change orders used to update a property's assessment.
