Engineer's Report

Public Comments:

Bob Flukas of Lindsay Road asked why the deck hockey rink is located on his property line and not in the expanse behind the basketball court. He asked about lights.

Mrs. Meyers said there are no lights.

Mr. Wells said he talked to Denise about moving the rink into the back corner so it is not as close to his backyard.

Mr. Flukas said there are two or three deck hockey rinks in the area but they are not affecting homes. They will be cutting parking by one-third. He asked if there are any plans to add more parking.

Mr. Wells said he received calls when the notification letters went out. Mr. Flukas has young grandchildren playing in his back yard.

Mr. Lennon said he does not know what he means by the back corner. He said that is a slope area.

Mr. Flukas said they have eighty or ninety feet behind the basketball court.

Mr. Wells asked if there is any way to move it so it is not abutting these properties.

Mr. Lennon said it is located there for a variety of reasons. There was a lot of time put into these plans.

Mrs. Fitzgerald said the original design was changed because of the way the sun rises and sets.

Mr. Lennon said there are specific standards for playing fields. It depends on the sun at certain times of day. They followed the standards and designed the field so it is accepted by the association.

Mr. Flukas said they have kids playing baseball there.

Mr. Castello said the baseball fields were built thirty years ago before they had standards. If a child is hurt and the township did not follow the standards, they would be liable.

Mr. Wells said they could be able to move 100 feet over next to the basketball court. He is trying to get it out of people's back yards.

Mr. Calabria asked if they could flip-flop the parking.

Mr. Lennon said there were a lot of meetings between his firm and the township and they delivered five or six layout alternatives and this was the best. They can change the plan but it will delay it.

Mr. Flukas said they are not thinking about the residents. Lights are going up sooner or later and they will be in his back yard.

Mr. Wells said they did not see a drawing until last week. They said they were going from an ice rink to a deck hockey rink. He spoke to Mr. Flukas' wife and she is very reasonable. The residents are very accepting of this but they do want it in their back yards.

Mr. Lennon said they would have to revise the drawings and sent them to DCNR.

Mrs. Piet said she has lived at the corner of Lindsay and Park Road since 1950 and she was happy with the township's decision to build a park. She has been living with dirt and gas fumes and the brunt of all the traffic. She said she is tired of cleaning. The have a beautiful park with what they have now and she cannot see putting something that close to homes where they cannot have company or sit in the back yards. People park on her lawn on the 4th of July.

Mr. Wells said Mrs. Piet is very patient and she has never complained. She has lived in a dusty, dirty area for the past year and she cannot open windows. She called when she found it would abut her back yard.

Mrs. Piet said they already have enough to entertain children and adults.

Tim Clark of 514 Lindsay Road said it is great that they switched from an ice rink to deck hockey. He asked if they are planning to rent to leagues.

Mrs. Meyers said they will see what happens when they get it in if it's not used all the time. If they moved it, one goalie would always be looking into the sun and nobody would want to pay here. They could probably solve the problem with an air dome. Then they could have year round play. They can flood it and ice for a couple months of the year.

Mr. Clark said hockey is a growing sport in this area.

Mrs. Meyers said the park has to continue to add and continue to grow or people will go somewhere else. She said they are aiming for October, but if they have to resubmit it will be November. She said she would defer to Larry as he put all the work into this.

Mr. Lennon said the motion is to advertise subject to DCNR approval. They would be looking at one month to modify the drawings and another month to modify all the construction plans. They would have to revisit the parking issue.

Mr. Calabria said they could just flip-flop and it should not be a big issue.

Mr. Lennon said if that is what they want him to do, he will do it. They work through a committee process and they have been working with the Parks Committee. They will have to tell the DCNR they are going to pull the drawings and resubmit.

Mr. Calabria asked why they cannot just submit a change.

Mr. Lennon said he would not do that. They are the approving authority. They cannot advertise until the DCNR approves it. They have to pull and resubmit it.

Mrs. Fitzgerald said the Parks Committee was aware of this design.

Mrs. Meyers said everything was set up where they thought was the best layout. She asked if the new plans could be ready for the next meeting.

Mr. Lennon said he thinks so. He needs to know which alternate they want. He asked if there is a problem with the proximity of the playing fields together.

Richard Thomas of Lindsay Road said he didn't know anything about this until a week ago. Why did the township prepare plans and not talk to the residents? They are taxpayers and should have been asked.

Mr. Lennon said this is a joint grant with the ADA Playground. It is a requirement of the grant that they have to be bid together.
