<u>Discuss design being presented for the Bower Hill and Kane Blvd. traffic light prior to being submitted to Penndot.</u>

#### Mike Mudry; Traffic Control and Design

Mr. Mudry presented the traffic signal design for Bower Hill and Kane Blvd. Mr. Mudry stated with the restraints provided he decided to go with the old school design because of the curve within the roadway. The most cost efficient approach would be to have two poles in opposite corners of the road, so if you're driving up hill on Bower Hill Road the first pole would be on your right side and the other pole would be on your far left side by the church. There will be a stand guide running over the intersection which would hold all the wiring and the traffic lights. This design is not a typical design however; it does meet all the standards and requirements.

Mrs. Caruso asked what the time frame would be to get this project started.

Mr. Mudry said that they are at the mercy of Penndot, if everyone is okay with the design I presented tonight I can have it submitted to Penndot this week, and he would expect to hear back from Penndot by end of June. Mr. Mudry would be able to have bids ready by July. Mr. Mudry feels that the project could be completed mid November approximately.

Mr. Wells asked what the price would be if this design is approved.

Mr. Mudry replied that it would be \$200,000.
