

Now that the weather will be improving we can begin to look forward to the upcoming events at the park such as the Easter Egg Hunt, Memorial Day Parade, Public Safety Day, Fourth of July, Movies in the park, and Octoberfest.

I also want to thank all of our public service personnel who do such a fine job of protecting the residents of Scott Township. I can't thank the Public Works, Police, Fire Departments, EMS Departments and all of our first responders for the great jobs they do protecting us all year round.

We truly have a wonderful home here in Scott Township and I pledge my continuing efforts to work with the Administration and other Commissioners to keep it that way.

Our second effort was collaboration with VIS Signs/Visual Information Systems on a new LED Display Message Board located at the entrance to Scott Township Municipal Building. This message board will enable Scott Township Government Administration to quickly disseminate public service announcements such as Amber alerts or the relocation of an event held at Scott Township Park or Municipal Building.

An important component to assist us with the use of information technology and social media is the recent hire of Jim Stoker as our Information Technology Technician Manager. Recently, Jim agreed to develop a Public Agency Account on the Social Media website "Nextdoor" to help Scott Township communicate with residents on important issues such as Crime and Safety.

Working together with Pennsylvania State Representative Anita Kulik and Allegheny County Councilman Pat Catena, who provided the funding, Denise and I were able to purchase a Standalone Automatic External Defibrillator (AED) for the Scott Township Municipal Building.

I am truly proud of all of the First Responders, and our Police Department who were on scene. I would also thank my fellow commissioners for their solace during this tragedy.

Because of the tragedy, I reached out to my friend and confidant, Pennsylvania State Representative Dan Miller. Dan also represents District 1 of the 7th Ward, and Dan is an active member of the Mt Lebanon Fire Department.

Dan and I discussed several issues including Mt Lebanon's "After the Fire-First Night Free Program". This Program allows residents one free night at the Crowne Plaza Hotel in Bethel Park to eliminate the burden of wondering where a family is going to stay after a disaster strikes.

Shortly thereafter, Denise Fitzgerald and I collaborated and I am glad to report that we were able to implement an identical program here in Scott Township.

The 2017 Road Paving Program was completed in conjunction with new and updated road/pedestrian directional signage to identify traffic patterns and road hazards.

We again issued Twin Hills Controlled Archery Hunt Letters as per Court Ordered Mandate.

At Cochran Hall we installed (2) New Hooded Sewer Inlets to help deal with storm water runoff and keep debris from clogging both Sewers and causing flooding.

The highly anticipated annual Orchard Spring Road Halloween Party was enjoyed by all. This year the event was led by planning committee members; Rachel Schwartzmiller, Colleen Hough, and Melody Mackin which raised \$350.00 for the Scott Township Public Library. This family oriented event allows the community to come together for an afternoon of costumes, games, food, but mostly good old fashioned neighborly fun. District Magistrate Craig Stephens and his family were on hand, and the Judge cooked his infamous hot dogs.

I would also like to thank the Janco family for their participation, especially Greg Janco and his compilation of a collage to commemorate the event which was proudly displayed in the lobby of the Scott Township Municipal Building, and the Scott Township Public Library. My wife Jeanette and I were again honored to participate as a costume judges.

In the lower Parklet on Orchard Spring Road, we honored and commemorated the memory of the late Marge PASTOR and Jane SLATER and their families by installing a plaque on one of the Parklet benches.

# Gode Enforcement

When you are spring cleaning, keep in mind that it is unlawful to have unsightly debris or junk in your yard or around your property. It is also illegal to have unregistered or uninspected vehicles on your property.

Haul away bags or dumpsters can be placed on your property for clean up or a construction project for a maximum of **10 days.** 

PODS are a convenient way to pack your belongings for storage elsewhere. Again, they can be on your property for a maximum of **10 days.** You **cannot** use trailers for storage on your property.



Parking on your lawn or in your yard is illegal and the Police Department and Code Enforcement are working together to step up enforcement. Officers will be looking for illegally parked cars evenings and week-ends and furnishing the information to the Code Enforcement Office.

## **Rental Properties**

Under PA Act 21, effective June 1, 2015 owners of all rental properties will be required to install carbon monoxide detectors. This will become part of the inspection process.

## Recycling

Please place your recyclables in the bin with the lid opening toward the street with a minimum of three feet between each container and other objects. Do not park your

vehicle near the container. Do not leave additional recycling on top of the lid or beside the bin. The truck has a mechanical arm that reaches the bin so it is very important that you follow the placement instructions. Wrongful placement of the recycling container will result in being left on your property.



### Winter Days

During the winter season please do not plow the snow from drive-ways or other property areas onto the streets and public ways as reflected in Ordinance #1486-01. Not following the Ordinance makes it difficult for our Public Works staff to remove all the snow off our streets properly. In addition, please be aware that snow must be removed within 24 hours of a snow fall from all property owned areas.






# The Scott Conservancy

Home to a Natural Woodland Area with Walking Trails



Bower Hill VFD is one of 3 Fire Departments that serve the over 17,000 Scott Township residents and businesses. Bower Hill is a completely volunteer fire department with approximately 40 members who can respond to calls for assistance from the residents and businesses, regardless the time of day.

Here are some ways that you can support Bower Hill so that we can continue to provide fire service to the residents and businesses of Scott Township.

### SOME OF THE WAYS YOU CAN SUPPORT BOWER HILL VFD

- 3. UNITED WAY Bower Hill VFD is a member of the United Way and our United Way Donor Number is 2341.
- **4. AMBULANCE MEMBERSHIP** By becoming a member of Bower Hill you can receive medically necessary ambulance transports and we will accept what your insurance carrier pays and not bill you for the balance of the ambulance transport. We provide ambulance services and transport whether you are or are not a member of Bower Hill.
- **5. DEPARTMENT MEMBERSHIP** Become a member! We have several positions that you might be able to fill. Not everyone in our department is an interior firefighter. Several members provide help on the exterior of the fire ground as well. Helping with many tasks involved in fighting a fire or at an accident scene. If you would like to talk to someone about joining please call 412-221-3497 and someone will contact you shortly. We supply the training you need at no financial cost to you!

We also participate in the CCAC FireVest scholarship education program for anyone attending CCAC, not necessarily involved in Fire Service education. Want to check out what we do? Please feel free to stop by the station on the  $2^{nd}$ ,  $3^{rd}$ , and  $4^{th}$  Wednesday evenings of each month when we have drill. We start our training at 7:00 PM.

**6. JUNIOR DEPARTMENT** — We also have a Junior Fire Department Program for anyone ages 14 to 18. These juniors participate in the drills with the senior members (except for anything dealing with active fire) and take the same trainings as the senior members do at the Fire Training Academies in Allegheny or Washington Counties. Many of our Junior Members have pursued the Fire Service as a career, with some even getting their Associates or Bachelor's degree in the Fire Service. All of our current Line Officers have participated in Junior Fire Programs, many with Bower Hill.

## INFORMATIONAL ITEMS:

- **1. PHONE CALLS** Bower Hill Volunteer Fire Department DOES NOT make any phone calls to residents asking for financial support. Our only contact is by the mailings that we send in October and January regarding our membership program.
- 2. HOUSE NUMBERS Check your house numbers and see if they are visible from the curb both night and day. This is vitally important in getting the right services to you when needed.
- 3. SMOKE ALARMS AND CARBON MONOXIDE DETECTORS Please remember to change the batteries in both your smoke alarms and carbon monoxide detectors when you change your clocks. This will insure working alarms in your home. It is recommended that you replace your smoke and carbon monoxide detectors every 7 to 10 years.

Leaves can only be placed in 30-gallon compostable paper bags and tree trimmings are to be bundled and tied with twine in manageable 3' to 4' foot lengths. Each bag and/or bundle to be picked up should not exceed 40 pounds.


Recycle or properly dispose of household products that contain chemicals, such as insecticides, pesticides, paint, solvents, and used motor oil and other auto fluids. Don't pour them onto the ground or into storm drains.

Excess fertilizers and pesticides applied to lawns and gardens wash off and pollute streams. In addition, yard clippings and

- Don't overwater your lawn. Consider using a soaker hose instead of a
- Use pesticides and fertilizers sparingly. When use is necessary, use these chemicals in the recommended amounts. Use organic mulch or safer pest control methods whenever
- Compost or mulch yard waste. Don't leave it in the street or sweep it into storm drains or streams
- Cover piles of dirt or mulch being used in landscaping projects

Washing your car and degreasing auto parts at home can send detergents and other contaminants through the storm sewer system. Dumping automotive fluids into storm drains has the same result as dumping the materials directly into a waterbody.

Education is essential to changing people's behavior. Signs and markers near storm drains warn residents that pollutants entering the drains will be carried untreated into a local waterbody.

## Residential landscaping

Permeable Pavement—Traditional concrete and asphalt don't allow water to soak into the ground. Instead these surfaces rely on storm drains to divert unwanted water. Permeable pavement systems allow rain and snowmelt to soak through, decreasing stormwater runoff.

Rain Barrels-You can collect rainwater from rooftops in mosquitoproof containers. The water can be used later on lawn or garden areas

Rain Gardens and Grassy Swales—Specially designed areas planted

with native plants can provide natural places for rainwater to collect and soak into the ground. Rain from rooftop areas or paved areas can be diverted into these areas rather than into storm drains

Vegetated Filter Strips—Filter strips are areas of native grass or plants created along roadways or streams. They trap the pollutants stormwater picks up as it flows across driveways and streets.



Dirt, oil, and debris that collect in parking lots and paved areas can be washed into the storm sewer system and eventually enter local

- Sweep up litter and debris from sidewalks, driveways and parking lots, especially around storm drains.
- Cover grease storage and dumpsters and keep them clean to avoid leaks.
- Report any chemical spill to the local hazardous waste cleanup team. They'll know the best way to keep spills from harming the environment.

Erosion controls that aren't maintained can cause excessive amounts of sediment and debris to be carried into the stormwater system. Construction vehicles can leak fuel, oil, and other harmful fluids that can be picked up by stormwater and deposited into local waterbodies.


- Divert stormwater away from disturbed or exposed areas of the construction site
- Install silt fences, vehicle mud removal areas, vegetative cover, and other sediment and erosion controls and properly maintain them, especially after rainstorms.
- Prevent soil erosion by minimizing disturbed areas during construction projects, and seed and mulch bare areas as soon as possible.





Lack of vegetation on streambanks can lead to erosion. Overgrazed pastures can also contribute excessive amounts of sediment to local waterbodies. Excess fertilizers and pesticides can poison aquatic animals and lead to destructive algae blooms. Livestock in streams can contaminate waterways with bacteria, making them unsafe for human contact.

- Keep livestock away from streambanks and provide them a water source away from waterbodie
- Store and apply manure away from waterbodies and in accordance with a nutrient management plan.
- Vegetate riparian areas along waterways
- Rotate animal grazing to prevent soil erosion in fields.
- Apply fertilizers and pesticides according to label instructions to save money and minimize pollution.



Uncovered fueling stations allow spills to be washed into storm drains. Cars waiting to be repaired can leak fuel, oil, and other harmful fluids that can be picked up by stormwater.

- Clean up spills immediately and properly dispose of cleanup materials.
- Provide cover over fueling stations and design or retrofit facilities for spill containment
- Properly maintain fleet vehicles to prevent oil, gas, and other discharges from being washed into local waterbodies.
- Install and maintain oil/water separators.



Improperly managed logging operations can result in erosion and

- Conduct preharvest planning to prevent erosion and lower costs.
- Use logging methods and equipment that minimize soil disturbance.
- ♦ Plan and design skid trails, yard areas, and truck access roads to minimize stream crossings and avoid disturbing the forest floor.
- Construct stream crossings so that they minimize erosion and physical changes to streams.
- Expedite revegetation of cleared areas.



## **DELINQUENT TAXES:**

Scott Township taxes not paid by March 31<sup>st</sup> each year will be turned over on April 1st to Attorney Patricia McGrail and Associates.

Chartiers Valley School taxes not paid by June 30th will be turned over to Jordan Tax Service, **EXCEPT FOR THOSE ON THE INSTALLMENT PLAN.** 

**MuniciPay:** We accept credit cards for **Township tax only.** You may pay using one of these credit cards (**Visa, MasterCard, Discover or American Express**) for a convenience fee of **2.65%** of the total tax amount with a minimum fee of \$3.00. This form of payment **CANNOT** be paid online; instead, you must either call or come into our tax office and we will assist you.




